## Cemetery Fees

The following fees must be paid in advance of Dealer accessing a CCA property for the purpose of installing a foundation.

### Cemetery Services:

CCA employees to verify Ownership of Place of Interment (POI), record the foundation in the cemetery section book and other records (CROSS), physically verify location of for the installation of the foundation, cut the sod, inspect each phase of the installation process, inspect and verify that no damage to adjacent POI's or CCA property and all debris removed, inspect final grading and seeding (seed to meet cemetery specifications). All inspections must be completed within a reasonable time to completion of the work by monument dealer.

Flush or Raised/Pillow Memorial	Two Hundred Fifty Dollars	(\$250.00);
Raised Monument	Three Hundred Fifty Dollars	(\$350.00);
Estate Monument	Four Hundred Dollars	(\$400.00);
Estate Mausoleum	Five Hundred Fifty Dollars	(\$550.00).

Ramping is charged at the rate of Forty-five Dollars (\$45.00) per sheet from the roadway to the installation site and labor plus equipment for a minimum crew of three (3) employees at the rate of One Hundred Seventy-five Dollars (\$175.00) per hour. All services exceeding the one hour minimum are assessed in fifteen-minute increments.
